Leadership Symposium	The Annual Leadership Symposium is a 2.5 day event held in August with officers from each chapter convening to kick off the academic year, participate in valuable leadership training, and share best practices for successful chapter management and engagement with the Grand Chapter. Funds will directly support this cornerstone event, which is provided at no cost to each chapter for one officer.
Professional Development	Allocated funds will support technological resources and associated expenses to create and expand a new proprietary professional development platform and series, which is being designed to benefit our entire student membership.
Scholarships	Visionary and Leader Partners can allocate up to \$5,000 of their annual gift towards scholarships. Funds will be used to establish, or increase the monetary value of existing, scholarships and awards granted to students through GIS.
General Support	Funds will be used for year-round support of our students, including staffing, membership management, technological needs, marketing efforts, and more. We continue to deepen and establish new partnerships with organizations that are committed to the future of the industry and therefore to a robust talent pipeline and to widespread educational access.
